

BLOCK TREE WEBSITE TERMS OF USE

Introduction:

This website ("Website") is owned and operated by Block Tree Ltd and its associated companies ("Block Tree"). Each reference in these terms of use to this Website includes all materials that Block Tree makes available to you on this Website

By using this Website, you agree to comply with these terms of use. Please check this page each time you use this Website, as Block Tree may update these terms from time to time.

If you carry out any transaction through this Website, such transaction may be subject to additional terms and conditions, which you will be asked to read and accept at the relevant time. To the extent of any inconsistency with these terms, the terms of the transaction apply to such transaction and any matters connected with it.

Your Obligations:
